

# Water Withdrawals for Self-Supplied Industrial Manufacturing in Michigan: 2004

#### Introduction

This report has been prepared by the Michigan Department of Environmental Quality to summarize selfsupplied manufacturing information compiled in Michigan's Water Use Reporting Program. The overall goal of the program is to establish an environmental baseline and continuing assessment of major water uses in the state, including power generation, industrial, irrigation, and public water supply. This fulfills key requirements of the Great Lakes Charter, a regional agreement signed by the Great Lakes states and Canadian provinces in 1985, and Michigan's water use reporting law (Part 327, Great Lakes Preservation, Natural Resources and Environmental Protection Act, 1994 PA 451, as amended).

Detailed water use information from the states and provinces is maintained by the Great Lakes Commission to facilitate regional policy-making and strengthen the legal defense against unwarranted diversions of Great Lakes water. It also provides essential water use information for state and regional water resources planning to support power generation, industrial, irrigation, and public water supply activities in a manner consistent with sound environmental management.

## Background

The manufacture of products in Michigan requires water resources for processing, washing, fabrication, cooling, sanitation, and other purposes. Nearly all industries utilize water as an essential production material, including large-volume users producing steel, automobiles and transportation equipment, chemical and allied products, paper and allied products, mining resources, and petroleum refining. Manufacturing water is provided by public water supply systems, or in many cases is self supplied from industrial wells or surface water intakes. Some manufacturing facilities use a combination of sources to meet various plant and employees needs.

At the national level, the Great Lakes Region has the largest volume of water withdrawn for selfsupplied industrial purposes, followed by the Ohio and Lower Mississippi Regions. While manufacturing withdrawals are comparatively large, a relatively small number of facilities accounts for the majority of water withdrawals. The portion of water withdrawn that is consumed (e.g. effectively lost due to evaporation, incorporation into products, etc.) varies with different manufacturing processes. In Michigan, the consumptive use rate is estimated between 10 to 15 percent for all facilities combined. Increasingly, process water is being recycled or recirculated, reducing water withdrawals in some manufacturing sectors.

During 1996-97, a comprehensive survey was conducted in Michigan to determine what portion of the state's 17,000 manufacturing facilities withdrew their own water, as opposed to receiving water from public water supply systems. The results of this assessment indicated that nearly 90 percent of the manufacturing facilities in the state receive water from public water supply systems. This was an unexpected result and emphasizes the importance of public water supply to Michigan's manufacturing economy. Of the remaining industries that utilize their own ground water and surface water resources, nearly 400 had the capacity to withdraw water above the Great Lakes Charter reporting threshold of 100,000 gallons per day averaged over a 30-day period. Ninety three percent of these facilities provided water withdrawal data for this report.

#### Michigan Summary

During 2004, 380 manufacturing facilities in Michigan reported self-supplied water withdrawals of 629 million gallons per day (MGD) for a variety of industrial water uses. This represents a slight increase in water withdrawals from 2003. Most of the manufacturing water was used by larger facilities, reflecting the national trend in manufacturing water use. About 68 percent of the water withdrawn for all self-supplied industries came from the Great Lakes and their connecting waters. Another 18 percent was withdrawn from inland lakes and streams, with the remaining 33 percent withdrawn from ground water.

Table 1 summarizes water withdrawals for self-supplied industries on a county basis. Wayne County had the largest withdrawals in 2004, accounting for 45 percent (284 MGD) of the self-supplied withdrawals in the state. The next largest water-withdrawal counties were Delta, Manistee, Kalamazoo, and Muskegon. Together, these four counties accounted for 21 percent of the total self-supplied manufacturing withdrawals statewide. While the Great Lakes predominated as a source of water for self-supplied manufacturing, facilities in counties such as Kalamazoo, Dickinson, Marquette, Monroe, Calhoun, Saint Joseph, and Allegan relied primarily on inland surface water and ground water sources.

Table 2 summarizes self-supplied industrial water use by U.S. Geological Survey hydrologic basins in Michigan. Water withdrawals were reported in 48 of the 57 basins in the state for 2004. The largest withdrawals were taken directly from the Detroit Watershed (Basin 04090004) and in the Kalamazoo Watershed (Basin 04050003). Together they accounted for 51 percent of the total self-supplied manufacturing withdrawals in the state. Four other hydrologic basins (Tacoosh-Whitefish, Manistee, Muskegon, and Pere Marquette-White) accounted for 21 percent of Michigan's self-supplied industrial water withdrawals. Reporting facilities in these four basins relied on a combination of Great Lakes, inland surface, and ground water for their supplies.

Information is presented in Table 3 for self-supplied manufacturing water use by Standard Industrial Code categories. Overall, there were 380 reporting industries in Michigan that included approximately 130,000 employees. Combined withdrawals for primary metals industries and paper and allied products accounted for 61 percent (382 MGD) of Michigan's self-supplied industrial water withdrawals in 2004. Industries that produce chemicals and their allied products, as well as mines and quarries, were also significant water users, utilizing about 25 percent (160 MGD) of self-supplied water withdrawals.

Longer-term trend analysis will be undertaken as self-supplied industrial water use data are compiled under Michigan's Water Use Reporting Program. This information will help fill the void created since U. S. Department of Commerce census reports for manufacturing water use were discontinued in 1982. When combined with other major water use sectors, it will also provide a continuing environmental baseline to ensure the continued protection and wise management of the waters of the Great Lakes Basin. 
